The Kingdom of Cambodia has received loan/grant from the Asian Development Bank (ADB) and a loan from Asian Infrastructure Investment Bank (AIIB) toward the cost of Greater Mekong Subregion Cross-Border Livestock Health and Value Chains Improvement Project (CLHVCIP), and it intends to apply part of the proceeds of these loans and grants to payments under the Contract for **Supply and Delivery of NCBC Semen Distribution Center Equipment, CAM-MAFF-CLHVCIP-G10**. *This procurement is included in the **approved Procurement Plan of the CLHVCIP project**. This bidding document has been prepared in accordance with the **ADB Procurement Regulations for Borrowers (2017, as amended from time to time)** and the Royal Government of Cambodia Standard Operating Procedures (SOP) for Externally Financed Projects.*
2. The **Ministry of Agriculture, Forestry and Fisheries (MAFF)/General Directorate of Animal Health and Production (GDAHP), Cambodia** and procurement will be conducted through Open Competitive Bidding (OCB) with national advertisement in accordance with the ADB Procurement Regulations, now invites sealed bids from eligible bidders for **Supply and Delivery of NCBC Semen Distribution Center Equipment (CAM-MAFF-CLHVCIP-G10)**.
3. Procurement will be conducted through Open Competitive Bidding (OCB) with national advertisement in accordance with the ADB Procurement Regulations for Borrowers (2017, as amended from time to time) and the Royal Government of Cambodia Standard Operating Procedures (SOP) for Externally Financed Projects. This procurement is included in the approved Procurement Plan of the CLHVCIP project.
4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.

6. Qualification requirements include:

- (i) The Bidder shall have successfully completed at least **two (2) contracts for the supply of similar goods within the last three (3) years (2023, 2024 and 2025)** of each contract **not less than USD 350,000.00**
- (ii) The Bidder shall have completed contracts for the supply of goods within the last **two (2) years (2024–2025)** with a **total cumulative value of not less than USD 1,340,000.00**.

(iii) **Financial Resources**

The Bidder shall demonstrate the availability of financial resources through either of the following:

- a. Liquid assets, including access to lines of credit or cash in bank accounts, of not less than USD 350,000.00, net of other contractual commitments; or
 - b. Credit arrangements with suppliers or manufacturers specifically for the goods to be supplied under the contract, valid for at least six (6) months after the bid submission deadline specified in ITB Clause 21.
- (iv) The Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.
 - (v) The qualification requirements are more completely described in the Bidding Documents.

7. A complete set of Bidding Documents in English may be purchased by interested bidders on the submission of a written application to the address given below and upon payment of a non-refundable fee USD 50.00 (Fifty US Dollars) or its equivalent in Cambodian Riel being KH Riel 200,000. The Bidding Documents will be collected in person or may be sent by email or courier, at the discretion of the bidder, but the bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.

The Royal Government of Cambodia (RGC) and the Asian Development Bank (ADB) will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by them, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
