Supply and Delivery of Soil and Forage Laboratory Testing Equipment

1. The *Kingdom of Cambodia* has received a loan from the Asian Development Bank (ADB) and Asian Infrastructure Investment Bank (AIIB) toward the cost of the Greater Mekong Subregion Cross-Border Livestock Health and Value Chains Improvement Project (CLHVCIP), and it intends to apply part of the proceeds of this *loan/ grant* to payments under the Contract for the **Supply and Delivery of Soil and Forage Laboratory Testing Equipment, Contract No. CAM-MAFF-CLHVCIP-G13**.
2. The goods are required by delivery within 45 calendar days from the date of contract signing.
3. Interested qualified eligible suppliers are invited to obtain a copy of the bidding documents free-of-charge from the address given below by submitting a written application. Except for the submission of a written application, there shall be no other conditions for obtaining the bidding documents.
4. To be considered eligible and qualified a Supplier must:
The Supplier shall demonstrate experience in supply of similar goods and capacity to perform the contract."
 - (i) Meet the eligibility criteria ADB
 - (ii) Have completed at least two (2) contracts for the supply of similar goods during the preceding three (3) years (**2023, 2024, and 2025**), of a value of not less than **USD 41,000.00** each contract.
 - (iii) Have completed contracts with a total cumulative value equal to at least **USD 162,000.00** in the preceding 2 years (**2024 & 2025**).
 - (iv) Not be under any notice of suspension or disbarment issued by the *Royal Government of Cambodia* or *Asian Development Bank*.
5. Quotations must be delivered to the address given below on or before **16:00 pm on 22nd September 2026**. Late Quotations will be rejected. Quotations will be opened in public immediately thereafter at the address given below in the presence of the Suppliers' representatives who choose to attend. The Supplier shall not have the option of submitting their quotations electronically.
6. The Purchaser shall award the Contract to the Supplier whose offer has been determined to be the lowest evaluated quotation and is substantially responsive to the Bidding Documents, provided further that the Supplier is determined to be qualified to perform the Contract satisfactorily.
