The Kingdom of Cambodia has received loans/grants from the Asian Development Bank (ADB) and the Asian Infrastructure Investment Bank (AIIB) toward the cost of the Greater Mekong Subregion Cross-Border Livestock Health and Value Chains Improvement Project (CLHVCIP), and it intends to apply part of the proceeds of these loans and grants to payments under the Contract for **Supply and Delivery of NCBC Liquid Nitrogen Plant, CAM-MAFF-CLHVCIP-G05**.
2. The **Ministry of Agriculture, Forestry and Fisheries (MAFF)/General Directorate of Animal Health and Production (GDAHP), Cambodia** now invites sealed bids from eligible and qualified bidders for the Supply and Delivery of NCBC Liquid Nitrogen Plant, CAM-MAFF-CLHVCIP-G05.
3. Procurement will be conducted through National Competitive Bidding Procedures specified in the RGC's Standard Operating Procedures on Procurement for All Externally Financed Projects/Program, under the laws and regulations governing public procurement within the Kingdom of Cambodia, and in accordance with the Financing Agreement and Procurement Regulations of **Asian Development Bank (ADB)**.
4. This invitation is open to all eligible bidders from eligible source countries as described in the Bidding Document.
5. Interested eligible bidders may obtain further information from Mr. Mey Bunthim, Procurement Officer, **PMU, CLHVCIP**, bunthim.mey2012@gmail.com, copy to bounsokhom168@gmail.com and inspect the Bidding Documents at the address given below during working hours from 7:00-11:30 hours and 14:00 – 17:30 hours.
6. Qualification requirements include:
 - (i) The Bidder has satisfactorily completed at least two contracts for the supply of similar goods in the preceding three years (2023, 2024 and 2025) of **not less than USD 190,000.00**.
 - (ii) The Bidder has completed contracts in the total cumulative amount equal to at least **USD 740,000.00** in the preceding two years (2024 and 2025).
 - (iii) The Bidder has availability of liquid assets through either:
 - a. access to a line of credit or cash in bank account of an amount at least **USD 190,000.00**, net of other contractual commitments; or
 - b. credit terms with vendors specifically for the goods to be supplied under the contract, and valid for at least 6 months after the deadline date for submission of bids specified in ITB Clause 21.
 - (iv) The Manufacturer of the offered goods, if a different entity from the Bidder, has experience of at least 3 years in the manufacturing of similar goods.

The Bidding Documents will be collected in person or may be sent by email or courier, at the discretion of the bidder, but the bidder has to deposit the fee at the above bank account and to pay for courier charge by his/her arrangement as appropriate. Other than payment of the non-refundable fee specified above, there shall be no other conditions for purchase of the bidding documents.

The Government and/or the Asian Development Bank (ADB) will respectively declare a bidder ineligible either indefinitely or for a stated period of time, to be awarded a contract financed by them, if it at any time they determine that the bidder has engaged in corrupt or fraudulent, coercive, collusive or obstructive practices in competing for or in executing a contract.
